DOGGER BANK AND PROPOSED CABLE ROUTE

All Mariners are advised that Sofia Offshore Wind Farm Limited (SOWFL) has contracted Ocean Ecology Limited (OEL) to carry out a seabed habitat survey off the north-east coast of the UK for the proposed Sofia Offshore Wind Farm (SOWF) site.

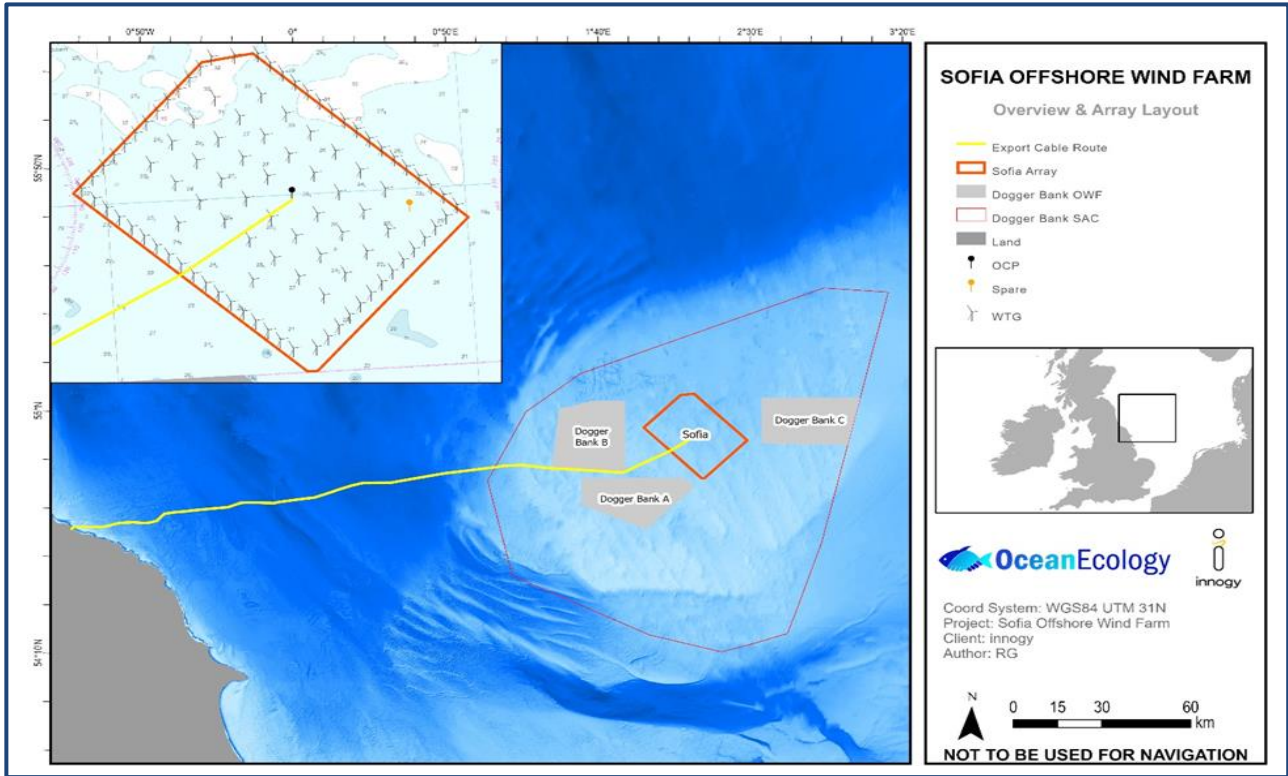


Figure 1 Chart of Intended Working Area for the Activity. Export cable route (yellow) and SOWF array (red).

Please be advised that from the 27th July 2021, Ocean Ecology will be undertaking seabed camera, grab sampling and Baited Remote Underwater Video (BRUV) surveys within the SOWF array area, along the SOWF export cable route and several reference locations, as shown in Figure 1 and as delineated by the boundary coordinates provided Table 1. Environmental surveys with a subsea camera system, grab sampler and BRUV housing and frame will be undertaken aboard the 26.0m survey vessel, 'DSV Curtis Marshall'. Full vessel details are presented in Table 3.

Mariners are requested to remain at a safe distance of 500m at all times.

This notification is intended for circulation to all interested parties undertaking activities in the vicinity of the planned survey works. If you would like further details regarding the surveys, please contact OEL's Operations Director using the contact details in this NtM.
